



## IMAGES/VIDEOS RIGHTS DISCLAIMER 2025

This document sets out and defines the conditions of use of the images and video assets provided by Norty and its associated brands, AWDIs, Pro RTX and Anthem via any of its communications - printed, digital or via direct download from any of its websites, links, or social media accounts- for the period of January 1st 2025 to December 31st, 2025 or until the licence stated on the image runs out.

- The images and video assets featuring models may only be edited to add logos and/or images, for B2B usage, in the garment area only. All models and backgrounds must be used in their original state and shall not be modified in anyway.
- The visual identities, in particular names and logos, are the asset of their respective proprietors and are therefore protected by intellectual property rights (trademarks, copyrights, design rights etc.). These images shall not be modified in any way.
- The use of the images and videos is restricted to commercial tools in relation to the brands' products only. The low-resolution images are for emailing, websites, commercial offers. The high-resolution images are for catalogues, sales brochures, printed cards. These images may not be used for any other purpose.
- The images or videos showing one or several models can be used Business-to-Business and Business-to-Consumer through social channels. No-use restriction applies to using any of the imagery in large scale mass marketing campaigns; also, imagery is not to be used for communications via the following channels: TV, streaming channels, satellite TV, Radio, Outdoor, Consumer/Mass market print media or billboards.
- Pack shots images can be used Business-to-Business and Business-to-Consumer and can be edited in any manner as long as this does not violate public order and morality, any law or regulation or any rights of third parties and/or
- Any use of the images/videos/logos beyond the aforementioned is prohibited without the prior written consent of the proprietors. The assets provided may not be assigned to any third party without prior written approval.
- By downloading the images or videos provided, you agree to be bound by the terms and conditions set out in this document and to be solely responsible in cases of illegal use of them.

- As a user you must respect this legal framework. Due to varying restrictions across imagery and video assets, all lifestyle images and videos available for 2025 must be replaced or removed on or before the 31st December 2025. If the imagery is used after 31st December 2025 Norty Limited accepts no responsibility for the misuse of the assets and legal actions that may be taken as a consequence.
